**0-400 lbs.** Vendors in CT, ME, MA, NH, NJ, RI, VT = Ship via Fowler's Express.  
Vendors in Canada (QC & ON), DE, MD, NJ, NY, PA & VA, ship to Fowler's Express via Fed Ex Ground 3<sup>rd</sup> party billing.  
**Note:** Please email a request to [GlobalTraffic@wwwinc.com](mailto:GlobalTraffic@wwwinc.com) for the correct Fed Ex acct# for 3<sup>rd</sup> party billing.

**401-3000 lbs.** Vendors in CT, ME, MA, NH, NJ, RI, VT = Ship via Fowler's Express.  
Vendors in Canada (QC & ON), DE, MD, NJ, NY, PA & VA, ship to Fowler's Express using the table on page 2 for carrier selection.  
**Note:** LTL shipments must NOT consume more than 12 linear feet of trailer floor (750 cu. Ft.)
